NOTIFICATION

No. SO(M)HR&MAD 4-92/2014.- In exercise of the powers conferred under section 83 of the Christian Marriage Act, 1872 (XV of 1872), Governor of the Punjab is pleased to make the following rules:

- 1. Short title and commencement.- (1) These rules may be cited as the Punjab Christian Marriage (Preparation and Submission of Returns of Solemnized Marriages) Rules 2023.
 - (2) They shall come into force at once.
- 2. **Definitions.** (1) In the rules, unless the context or subject otherwise requires:
 - (a) "Act" means the Christian Marriage Act, 1872 (XV of 1872);
 - (b) "authorized person" means a person authorized to solemnize Christian marriages under section 5 of the Act;
 - (c) "CNIC" means the Computerized National Identity Card or Smart National Identity Card or National Identity Card for Overseas Pakistanis (NICOP), issued by NADRA;
 - (d) "Department" means the Human Rights and Minorities Affairs Department, Government of the Punjab;
 - (e) "Episcopal ordination" means an ordination of a Christian priest as a Bishop or an Archbishop, in accordance with rules, rites, ceremonies and customs of a Church;
 - (f) "Form" means the form appended to the rules;
 - (g) "identification number" means a unique identification number issued by the Department to an authorized person;
 - (h) "local government" means local government as defined and constituted under the Punjab Local Government Act 2022 (XXXIII of 2022);
 - (i) "NADRA" means the National Database and Registration Authority established under the National

Database and Registration Authority Ordinance, 2000 (VIII of 2000); and

- (j) "rules" means the Punjab Christian Marriage (Preparation and Submission of Returns of Solemnized Marriages) Rules 2023.
- (2) A word or expression used but not defined in the rules shall have the same meaning as assigned to it in the Act.
- 3. Preparation and submission of returns of marriages.- (1)
 An authorized person shall provide an authentic copy of certificate of marriage to each party and the concerned local government within three days of solemnization of marriage.
- (2) The authorized person shall maintain record of the marriages solemnized and also prepare returns of the marriages on Form-I. The record and returns shall be maintained and prepared manually and electronically.
- (3) The authorized person shall submit Form-I to the Department on monthly basis.
- (4) On receipt, the Department may analyze any Form-I and require any additional information, if necessary.
- 4. Database of authorized person.- (1) The Department shall maintain a database of authorized persons by issuing them an identification number linked with CNIC.
- (2) The Churches registered in Pakistan shall provide list of persons who have received Episcopal ordination to the Department on Form-II.
- (3) The Church of Scotland shall provide list of their clergymen to the Department on Form-III.
- (4) The Local Government and Community Development Department shall have access to the database mentioned in sub-rule (1) for immediate dissemination to concerned local governments for enabling them to register the marriages solemnized by authorized persons in the NADRA database.
